Books continue to flow in. The Friends will contribute 5K to the Party in the Park (09/17/2017). The Friends have paid for renewal of the museum pass software. The Friends will schedule a presentation for their 20K donation to the Library. At the request of the Library Director, the Friends will donate an amount (approx. 5K) to be used for staff development. The next book sale is June 9th through 11th.
